



Welcome to School's Out Summer Fun 2024

Thank you for choosing School's Out **Summer Fun** for your student. In response to your student's registration, we have placed deposits with this year's destination venues, purchased supplies for activities, and hired staff to provide quality care for your student. **As a result, we will NOT issue any refunds/credits/transfers in the event you cancel your student's registration due to absences, illnesses, vacations or no shows. Online registration must be received one week prior to the start of each new session.** (e.g. The activity week of June 17, 2024 requires online registration be received NO LATER than Monday, June 10, 2024). Daily late fees apply for registrations made after Mondays before each new session. No registrations will be accepted after Wednesday (for the following week).

School's Out aides and counselors will care for your student anywhere from 5-9 hours each day. To ensure a positive experience for all, please review the behavioral guidelines below with your student and feel free to share helpful information about your student with us (such as anxiety issues, fears, swimming experience, etc.).

By registering your student for School's Out Summer Fun, you agree to the Behavioral Guidelines listed below and posted on the School's Out website:

Communication is a key to every great relationship. Please contact us immediately if any issues or concerns arise as we will commit to the same. It is an expectation that your student will exhibit respectful behaviors while participating in the School's Out program(s). Should your student display behavior we deem as inappropriate, we will make every effort to resolve the issue and work with your student to understand the situation. We will communicate any necessary information at pick-up that day. School's Out staff reserves the right to remove a student from the general setting out of concern for safety and in those cases, you will be immediately notified. You will be asked to pick your student up immediately if there is an issue with extreme/aggressive behavior, bad language, or physical contact. Together, we will discuss future program participation.
